Applicants and/or their sales persons, agents, or representatives shall submit and consent to fingerprinting.

The applicant shall provide three (3) 2" by 3" photographs showing the head and shoulders of the applicant and/or his representative/s who are to be licensed. Said photographs must be current and shall exhibit a close resemblance of such person/s.

Applicants who are considered to be transient merchants and/or who intend to operate from a fixed location shall comply with Section 11.2.6 attached.

FEES

An application fee of \$50.00 shall be made payable to THE TOWNSHIP OF PENNSVILLE and submitted with this completed application to the Township Clerks Office. All fees are non-refundable.

Upon submission of the application and fee, the applicant will be directed to the Pennsville Police Department where he/she will be provided with an application for fingerprinting through Sagem Morpho to obtain a criminal background check. A fee of \$41.70 for fingerprinting/criminal history search is required by Sagem Morpho/New Jersey State Police at the time of fingerprinting. Must be paid by money order to Sagem Morpho. Locations where fingerprinting is conducted will be provided.

Total fees per applicant are \$91.70
