Title: AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF PENNSVILLE AMENDING CHAPTER 14 SECTION 5-11 OF THE REVISED ORDINANCES OF THE TOWNSHIP OF PENNSVILLE WHICH SECTION IS ENTITLED "ADDITIONAL REQUIRED INSPECTION AND FEES" AND WHICH AMENDMENT WILL DELETE THE "PERMIT FEES NOT REGULATED BY DIVISION OF FIRE SAFETY" AND THE "PROPANE EXCHANGE FACILITIES ANNUAL PERMIT FEE"

WHEREAS, the Township's Fire Marshall has advised the Mayor and members of the Township Committee of the Township of Pennsville that various fees currently set forth in Chapter 14 Section 5-11 of the Revised Ordinances of the Township of Pennsville are regulated by State statutes and therefore they can be deleted from the Section in question; and

NOW THEREFORE, BE IT ORDAINED by the Mayor and members of the Township Committee of the Township of Pennsville that:


1. Section 14.5-11 of the Revised Ordinances of the Township of Pennsville is hereby amended by deleting the Sections entitled "Permit fees not regulated by Division of Fire Safety" and "Propane Exchange Facilities Annual Permit Fee":

- 1) If any section or provision of this Ordinance shall be declared by a court of competent jurisdiction to be invalid, such decision shall not effect the validity of this Ordinance as a whole or any part thereof.
- 2) All Ordinances or parts of Ordinances heretofore adopted that are inconsistent with the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
- 3) This Ordinance shall be effective upon its final passage, adoption and publication in the manner prescribed by law.
