

ORDINANCE A-14-2020

Title: AN ORDINANCE OF THE TOWNSHIP OF PENNSVILLE, COUNTY OF SALEM, AND STATE OF NEW JERSEY, APPROPRIATING THE SUM OF \$100,000.00 FROM THE TOWNSHIP OF PENNSVILLE "WATER CAPITAL - CAPITAL IMPROVEMENT FUND" FOR THE REPAIR OF TOWNSHIP WELL #7

WHEREAS, the Township Committee of the Township of Pennsville previously adopted a budget which included a "Water Operating Capital Improvement Fund"; and

WHEREAS, the members of the Committee have determined that repairs are necessary to Township of Pennsville Well #7; and

WHEREAS, the members of the Committee have determined that the health, safety and welfare of the Township residents requires that the money listed below appropriated from the Water Capital, Capital Improvement Fund for the purpose stated hereinbelow,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and members of the Township Committee of the Township of Pennsville, County of Salem, and State of New Jersey, as follows:

(1) The sum of \$100,000.00 is hereby appropriated from the Township's "Water Capital, Capital Improvement Fund" which amount shall be used for the following purposes:

a) Paying for the repair of Township of Pennsville Well #7 at a cost not to exceed \$100,000.00.

(2) The Water Operating Capital budget of the Township of Pennsville is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies therewith. The resolutions promulgated by the Local Finance board showing in full detail the amended Water Operating Capital budget and capital program as approved by the Director of the Division of Local Government Services are on file with the Township Clerk and are available for public inspection.

(3) This Ordinance shall be effective after final passage and publication in accordance with the law.






FINAL RESOLUTION


WHEREAS, public hearing has been held thereon;
