

Ordinance A-7-2020

Title:

AN ORDINANCE OF THE TOWNSHIP OF PENNSVILLE, COUNTY OF SALEM, STATE OF NEW JERSEY, AMENDING CHAPTER 18 OF THE REVISED ORDINANCES OF THE TOWNSHIP OF PENNSVILLE WHICH AMENDMENT SHALL ADD SECTION 10 AND WHICH AMENDMENT WILL DESIGNATE THE SOFTBALL FIELD ON TUFTS ROAD AS ROBERT RAY FIELD

**WHEREAS**, the Mayor and members of the Township Committee of the Township of Pennsville have determined that it is both fitting and proper to name the Tufts Road Softball field after Robert Ray, deceased, based on his leadership and dedication to this community and the fact that he inspired all that knew him and more specifically his contributions as the recreation department director coordinating programs and maintaining duties until his retirement in 1992.

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and members of the Township Committee of the Township of Pennsville that Chapter 18 of revised ordinances of the Township of Pennsville is hereby amended to include section 18.4-10 which shall read as follows:

1. There is hereby established a designation of the Softball field on Tufts Road which shall hereinafter be named and designated as the Robert Ray Memorial Field.


This designation is made in recognition of Robert Ray's leadership and dedication to this community which was an inspiration to all who knew him and more specifically based on the fact that Robert Ray was the initial recreation department director, coordinating programs and maintenance duties until his retirement in 1992.

By this designation the area location shall be posted with an approved sign bearing the name Robert Ray Field

2. If any section or provision of this Ordinance shall be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of this ordinance as a whole or any part thereof.
3. All Ordinances or parts of Ordinances heretofore adopted and that are inconsistent with the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
4. This ordinance shall be effective after the final passage and publication in accordance with the law.
