Ordinance A-21-2022

Title: AN ORDINANCE OF THE TOWNSHIP OF PENNSVILLE, COUNTY OF SALEM, STATE OF NEW JERSEY, APPROPRIATING THE SUM OF \$210,000.00 FROM THE TOWNSHIP OF PENNSVILLE'S CAPITAL IMPROVEMENT FUND FOR THE PURCHASE OF A TRACTOR WITH ATTACHMENTS AND REPAIRS AND IMPROVEMENTS TO THE HVAC SYSTEM LOCATED AT THE PENNSVILLE TOWNSHIP TAX OFFICE

WHEREAS, the Mayor and members of the Township Committee of the Township of Pennsville (hereinafter Committee) have determined that the health, safety and welfare of the employees and citizens of the Township of Pennsville require that a tractor be purchased to be used by the Highway Department to maintain Township property and streets. It has also been determined that improvements are needed to the HVAC system at the Township's Tax Office; and


NOW THEREFORE, BE IT ORDAINED by the Mayor and members of the Township Committee of the Township of Pennsville, County of Salem, State of New Jersey, as follows:


1. The sum of \$210,000.00 is hereby appropriated from the Township of Pennsville's "Capital Improvement Fund" in the Current Capital Fund which amount shall be used to effectuate the development as stated above.
2. The Capital Budget of the Township of Pennsville is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies therewith. The resolutions promulgated by the Local Finance Board showing in full detail the amended capital budget and capital program as approved by the Director of the Division of Local Government Services are on file with the Township Clerk and are available for public inspection.
3. If any section or provision of this Ordinance shall be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of this ordinance as a whole or any part thereof.
4. All Ordinances or parts of Ordinances heretofore adopted and that are inconsistent with the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
5. This ordinance shall be effective after the final passage and publication in accordance with the law.


FINAL RESOLUTION


WHEREAS, a final hearing has been held thereon.
