NOW, THEREFORE, BE IT ORDAINED by the Mayor and members of the Township Committee of the Township of Pennsville, County of Salem, and State of New Jersey, that Ordinance A-1-2023 is amended as follows:

28A.	Animal Shelter Full-Time Worker	\$14.13 per hour


Section 3. Ordinance A-1-2023, except as amended herein, shall remain in full force and effect.




FINAL RESOLUTION
