Section 1

ADD

51A	Deputy Township Administrator	\$20,000.00
63	Flood Plain Administrator	\$21,000.00

Section 2. If any section or provision of this Ordinance shall be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of this Ordinance as a whole, or any other part thereof.


Section 3. Ordinance A-1-2023, except as amended herein, shall remain in full force and effect.


Section 5. This ordinance shall be effective upon its final passage, adoption and publication in the manner prescribed by law.




FIRST RESOLUTION


FINAL RESOLUTION


WHEREAS, a final hearing has been held thereon.
